\_\_\_\_\_ (*Required*) I agree that a lease signed by my tenant/occupant and me, or any other legal document signed by my tenant/occupant and me that is in a form acceptable to the public works director, shall serve as evidence of my authorization for the transfer of the water and sewer account for the real property described above into the name of such tenant/occupant. Such lease or other legal document will be retained by the City, together with this agreement, until such time as all taxes, charges, fees, penalties and interest for water and sewer service incurred by such tenant/occupant are paid in full.
